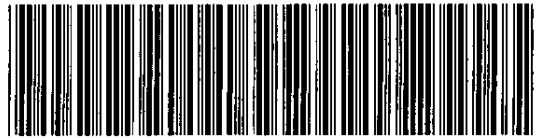

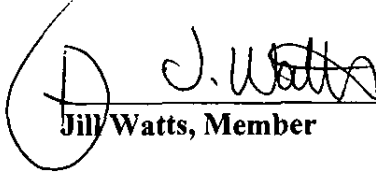
1. Name. The name of this limited liability company is **Golf Ball Empire, LLC** ("Company")
