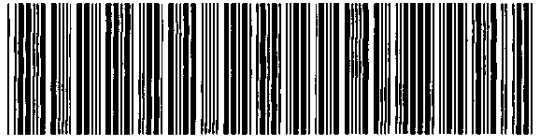

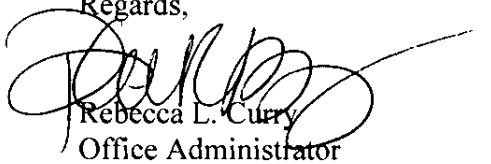

ARTICLES OF ORGANIZATION

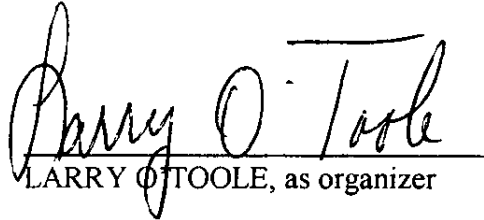
