### ARTICLES OF ORGANIZATION OF JAX SHOES 3, L.L.C.

Pursuant to the provisions of Chapter 608 of the Florida Statutes, for the purpose of forming a limited liability company under the laws of the State, the following are the Articles of Organization for Jax Shoes 3, L.L.C. (the "Company"):

1. <u>Name</u>. The name of the Company is Jax Shoes 3, L.L.C.
