
**ARTICLES OF ORGANIZATION
OF

Pursuant to the provisions of Chapter 608 of the Florida Statutes, for the purpose of forming a limited liability company under the laws of the State, the following are the Articles of Organization for Jax Shoes 3, L.L.C. (the "Company"):

1. Name. The name of the Company is Jax Shoes 3, L.L.C.
2. Mailing Address And Principal Place Of Business. The Company's mailing address and principal office shall be located at 6622 Southpoint Drive South, Suite 200, Jacksonville, Florida 32216.
