## ARTICLES OF ORGANIZATION FOR FLORIDA LIMITED LIABILITY COMPANY

The undersigned authorized representative, desiring to form a limited liability company pursuant to the provisions of the Florida Limited Liability Company Act, hereby submits, and files with the Florida Department of State, these Articles of Organization.

### ARTICLE I - Name

The name of the limited liability company created hereby (hereinafter, the "Company") is:

#### K-Nine Holdings, LLC

#### ARTICLE II - Purpose

The Company's business activities shall be all lawful activities, including without limitation, the acquisition, disposition, leasing, management, and maintenance of real property and personal property, and managing investment and portfolio assets. The Company shall have the same powers as an individual to do all things necessary to carry out its business and affairs, including without limitation, all powers permitted by the Florida Limited Liability Company Act, and the power to:

- (a) Sue and be sued, and defend, in its name.

  (b) Purchase, receive, lease, or otherwise acquire, own, hold, improve, use, and otherwise deal with real or personal property, or any legal or equitable interest in property, wherever located (c) Sell, convey, mortgage, grant a security interest in, lease, exchange, encumber or dispose of, all or any part of its property.

  (d) Purchase, receive, subscribe for, or otherwise acquire, own, hold, vote, use, in the property of the
- (e) Make contracts or guarantees, or incur liabilities; borrow money; issue its notes, bonds, or other obligations, which may be convertible into or include the option to purchase other securities of the Company; or make contracts of guaranty and suretyship which are necessary or convenient to the conduct, promotion, or attainment of the business of a corporation the majority of the outstanding stock of which is owned, directly or indirectly, by the contracting limited liability company; a corporation which owns, directly or indirectly, a majority of the outstanding membership interests of the contracting limited liability company; or a corporation the majority of the stock of which is owned, directly or indirectly, by a corporation which owns, directly or indirectly, the majority of the outstanding membership interests of the contracting limited liability company, which contracts of guaranty and suretyship shall be deemed to be necessary or convenient to the conduct, promotion, or attainment of the business of the contracting limited liability company; or make other contracts of guaranty and suretyship which are necessary or convenient

- Lend money, invest or reinvest its funds, and receive and hold real or personal property as security for repayment.
- Conduct its business, locate offices, and exercise the powers granted by Florida Statutes Chapter 608 within or without the State of Florida.
- Select managers and appoint officers, directors, employees, and agents of the Company, (h) define their duties, fix their compensation, and lend them money and credit.
  - (i) Make donations for the public welfare or for charitable, scientific, or educational purposes.
- Pay pensions and establish pension plans, pension trusts, profit-sharing plans, retirement plans, bonus plans, option plans, and benefit or incentive plans for any or all of its current or former managers, members, officers, agents, and employees.
- Be a promoter, incorporator, shareholder, partner, member, associate, or manager of any corporation, partnership, joint venture, trust, or other entity.
- (1)Make payments or donations or do any other act not inconsistent with law that furthers the business of the Company.

#### ARTICLE III - Address

The mailing address and street address of the principal office of the Company shall be as SSE Miracle Strip Parkway

Mary Esther, FL 32569

#### **ARTICLE IV - Duration**

The existence of the Company shall commence on April 27, 2009, and shall thereafter be perpetual, except as otherwise provided in the operating agreement pertaining to the Company.

#### ARTICLE V - Management

The Company shall be managed by a manager or managers, and the names and addresses of the manager or managers of the Company shall be maintained by the Company and kept with its business records.

#### ARTICLE VI - Members

The names and addresses of the members of the Company shall be maintained by the Company and kept with its business records.

### ARTICLE VII - Admission of Additional Members

The members may admit additional members in accordance with the operating agreement pertaining to the Company.

#### ARTICLE VIII - Ownership

The ownership interests of the members of the Company shall be in accordance with the membership or ownership certificates issued by the Company.

### ARTICLE IX - Registered Office and Agent

The address of the initial registered office of the Company in the State of Florida is 315 S. Hyde Park Avenue, Tampa, Florida 33606, and the name of the registered agent at such address is James P. Hines.

## **ARTICLE X - Membership Units**

The total number of membership units authorized to be issued by the Company shall be 10,000 units, par value \$.01. Each of issued unit shall entitle the holder thereof to one (1) vote at any meeting of the members. All or any part of said units may be paid for in cash, in property, or in labor or services at a fair valuation to be fixed by the manager or managers of the Company at a meeting called for such purposes. All membership units then issued shall be paid for and shall be nonassessable. The Company elects to have preemptive rights.
