ARTICLES OF ORGANIZATION
OF
THE ALCHEMY GROUP OF MELBOURNE, L.L.C.

The undersigned, acting as the organizers of this Limited Liability Company pursuant to Chapter 608 of the Florida Statutes, hereby form a limited liability company under the laws of the State of Florida and adopts the following Articles of Organization for such Limited Liability Company:

ARTICLE I - NAME

The name of the limited liability company shall be **THE ALCHEMY GROUP OF MELBOURNE, L.L.C.** (the "Company").

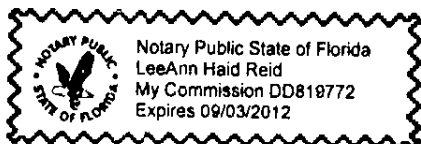

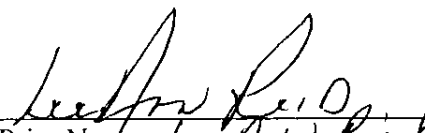

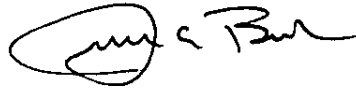
