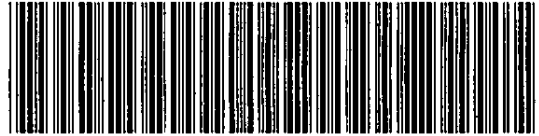

IN WITNESS WHEREOF, the undersigned authorized representative of the Member has made and subscribed this Article of Amendment this 16th day of July, 2009.

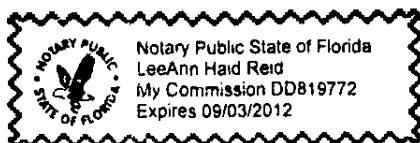
