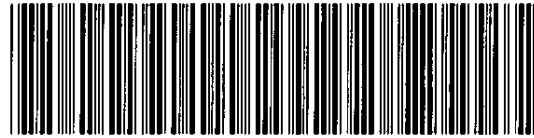

**AMENDED AND RESTATED ARTICLES OF ORGANIZATION**

**OF**

**THE BLUEPRINT SHOP, LLC**

Whereas, Articles of Organization of The Blueprint Shop, LLC, were filed with the Florida Department of State on May 1, 2009, effective June 1, 2009, and assigned document number L09000042265; and

Whereas, the Articles of Organization of The Blueprint Shop, LLC, erroneously stated that it was a "manager-managed" rather than a "member-managed" limited liability company, included a person who was listed as a manager who is not a member and misspelled names; and

Whereas, these Amended and Restated Articles of Organization were adopted on May 29, 2009, by the unanimous consent of all members, namely: Merlin M. Mitchell, Jr.; and Candice K. Mitchell.

Therefore, pursuant to Sections 608.411 and 608.4115 of the Florida Statutes, the Articles of Organization of The Blueprint Shop, LLC, are hereby amended and restated as follows:

**Article I. Name**

The name of this limited liability company is **The Blueprint Shop, LLC**, hereinafter also referred to as "the Company".

**Article II. Address of Principal Office**

The mailing address and street address of the principal office of the Company is 823 Thomasville Road, Tallahassee, Florida 32303.

**Article III. Initial Registered Agent and Address**

The name and street address of the initial registered agent of the Company is Merlin M. Mitchell, Jr., 823 Thomasville Road, Tallahassee, Florida 32303.

**Article IV. Management**

The Company shall be managed by the members.

**Article V. Limitation on Agency Authority of Members**

Pursuant to Section 608.4235 of the Florida Statutes, no member of the Company


shall be an agent of the Company solely by virtue of being a member.

**Article VI. Effective Date**


The effective date for this limited liability company shall be June 1, 2009.
