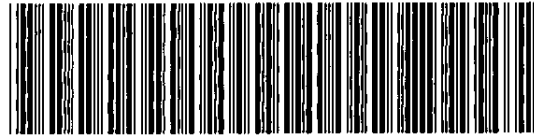

MANAGEMENT

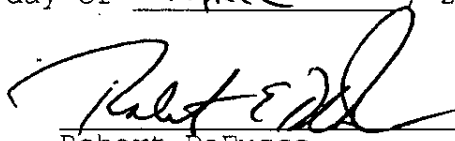
The management of the Company is reserved to the members of the Company in accordance with the Company's operating agreement.

ARTICLE VI

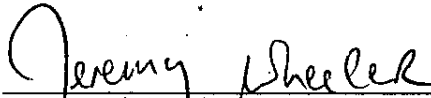
RELATIONSHIP OF ARTICLES OF ORGANIZATION TO OPERATING AGREEMENT

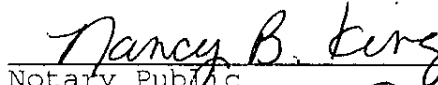
