ARTICLES OF ORGANIZATION OF IP 4 ASSOCIATES, LLC

The undersigned, desiring to form a limited liability company under and pursuant to the Florida Limited Liability Company Act, Chapter 608, Florida Statutes, does bereby adopt the following Articles of Organization.

ARTICLE I

The name of the Limited Liability Company shall be IF 4 ASSOCIATES, LLC.

ARTICLE II ADDRESS

ARTICLE VI ADMISSION OF ADDITIONAL MEMBERS

Additional Members may be admitted upon the approval of a majority of the Members of the Company, upon the written application of such new Member, in the manner set forth in the Operating Agreement of the Company.

ARTICLE VII ADOPTION OF OPERATING AGREEMENT
