**ARTICLE 5**  
**CONTINUATION OF BUSINESS**

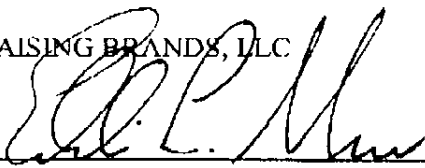

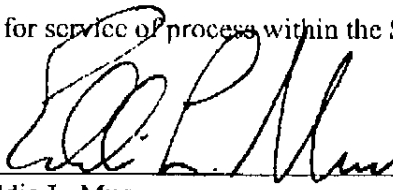
