**ARTICLES OF ORGANIZATION
OF

The undersigned initial managing member of the limited liability company hereby certifies that the Members, for the purpose of forming a limited liability company under the laws of the State of Florida, provided for the formation, rights, privileges, and immunities of a limited liability company for profit. The managing member further declares that the following Articles shall be the Charter and authority for the conduct of business of such limited liability company.

**ARTICLE I
NAME**


**ARTICLE VII
