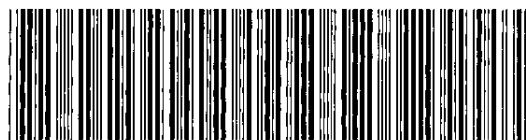


ARTICLE V
