ARTICLES OF ORGANIZATION OF

J&J CABINET WORKS LLC

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Florida Statutes Chapter 608, hereby makes, acknowledges, and files the following Articles of Organization.

ARTICLE 1 - NAME

The name of the limited liability company shall be **J&J CABINET WORKS LLC** ("Company").

ARTICLE 2 - ADDRESS

The principal place of business of the Company in Florida shall be 2824 Althea Avenue, Panama City, Florida 32405 and the mailing address shall be the same.

ARTICLE 4 - DURATION




