**Articles of Organization for LITTLE CHICKS SUMMER EXPERIENCE, L.L.C.  
a Florida Limited Liability Company (FS 608.407)**

The undersigned, desiring to form a limited liability company under and pursuant to Florida Statutes Chapter 608, entitled the Florida Limited Liability Company Act, do hereby adopt the following Articles of Organization for such company:

ARTICLE I – NAME

The name of this Company shall be LITTLE CHICKS SUMMER EXPERIENCE, L.L.C.

ARTICLE II – PURPOSE

This Company is formed to operate a summer camp for children, and to provide all manner of services in connection therewith. In addition, the Company shall be authorized to undertake any lawful business or enterprise allowed by the Laws of the State of Florida and the United States.


ARTICLE VIII – INDEMNIFICATION
