## Articles of Organization for LITTLE CHICKS SUMMER EXPERIENCE, L.L.C. a Florida Limited Liability Company (FS 608.407)

The undersigned, desiring to form a limited liability company under and pursuant to Florida Statutes Chapter 608, entitled the Florida Limited Liability Company Act, do hereby adopt the following Articles of Organization for such company:

#### ARTICLE I - NAME

Such indemnification may take the form of court costs, attorneys' fees or other expenses incurred by such person involved in such action, suit or proceeding.
