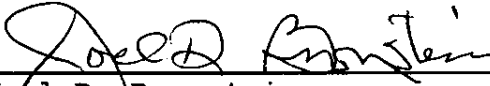
ARTICLE 5.

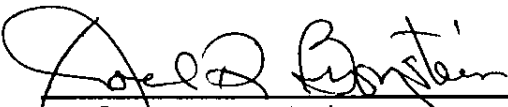
