**AMENDED AND RESTATED ARTICLES OF ORGANIZATION

**ARTICLE I - NAME** The name of the limited liability Company is MMSN INVESTMENT GROUP, LLC (the "Company").

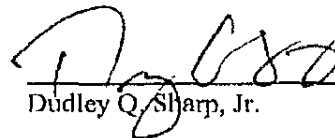

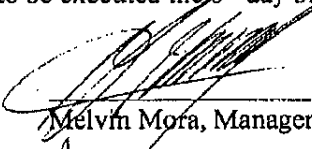
