4. Pursuant to Florida Statute Section 605.0701(1), Article 10.1(c), states:

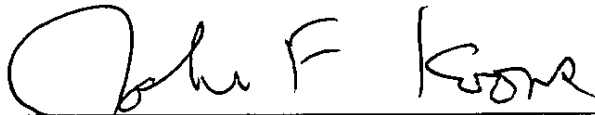
"The company shall dissolve only upon the occurrence of one or more of the following:
