ARTICLES OF ORGANIZATION

FOR

MJM PUBLICITY, LLC

Pursuant to Chapter 608 of the Florida Statutes, the undersigned, being an authorized representative of the sole member, executes and adopts the following Articles:

Article I -Name

The name of this limited liability company is MJM Publicity, LLC, a Florida limited liability company (the "Company").

Article II - Duration
