ARTICLES OF ORGANIZATION

OF

Under the provisions of F.S. 608.407 the undersigned files these Articles of Organization to form a limited liability company in the State of Florida and adopts the following as its Articles of Organization:

ARTICLE I -- NAME

The Company shall be dissolved on the death, bankruptcy, or dissolution of a member or manager, or on the occurrence of any other event that terminates the continued membership of a member in the Company, unless the business of the Company is continued by the consent of all the remaining members, provided there are at least two remaining members.

ARTICLE IX -- MANAGEMENT

The Company shall be managed by managers in accordance with the Operating Agreement adopted by the members for the management of the business and affairs of the Company.
