ARTICLES OF ORGANIZATION
OF
BRESSLER CUSTOM HOMES & DESIGN, LLC

The undersigned hereby certify that we have associated ourselves together for the purpose of becoming a limited liability company under the laws of the State of Florida, providing for the formation, rights, privileges and immunities of limited liability companies for profit and hereby adopt the following Articles of Organization for such limited liability company:

ARTICLE I
NAME AND PRINCIPAL OFFICE

The name of this limited liability company is **BRESSLER CUSTOM HOMES & DESIGN, LLC**, and its principal office and mailing address is located at 820 West Broadway, Suite 1000, Oviedo, Florida 32765.

ARTICLE II
DURATION

The existence of this limited liability company shall be perpetual, commencing upon the filing of the Articles of Organization by the Florida Department of State.

ARTICLE III
PURPOSE

The purpose of this limited liability company is to engage in any activity or business permitted under the laws of the United States and the State of Florida.

ARTICLE IV

**ARTICLE VII
INITIAL REGISTERED OFFICE AND AGENT**

The initial registered office of this limited liability company shall be located at 820 West Broadway, Suite 1000, Oviedo, Florida 32765, and the initial registered agent of the limited liability company at that address shall be PHILIP BRESSLER.
