ARTICLES OF ORGANIZATION

The undersigned, desiring to form a limited liability company under and pursuant to the Florida Limited Liability Company Act, Chapter 608, Florida Statutes, do hereby adopt the following Articles of Organization:

ARTICLE I. NAME

The name of the limited liability company is FLORA FAMILY LLC (the "Company").

ARTICLE II. ADDRESSES

The mailing address and the street address of the principal office of the Company are the following: 1826 Waterbury Lane, Orange Park, Florida 32003.

ARTICLE III. DURATION AND CONTINUATION

The period of duration for the Company shall be perpetual, unless terminated by the Members of the Company, and shall commence on May 18, 2009.

ARTICLE IV. REGISTERED AGENT AND OFFICE

The Company designates 1826 Waterbury Lane, Orange Park, Florida 32003, as the street address of the initial registered office of the Company and names Virginia F. Eddy as the Company's initial registered agent at that address to accept service of process within this state.

ARTICLE V. MANAGEMENT

The business operations of the Company shall be conducted, carried on, and managed by one or more Managers, who shall be elected annually by the Members of the Company in the manner prescribed by and provided in the Operating Agreement of the Company. ARTICLE VI. ADMISSION OF ADDITIONAL MEMBERS

Additional Members may be admitted upon the approval of a majority of the Members of the Company, upon the written application of such additional Members, in the manner set forth in the Operating Agreement of the Company.

ARTICLE VII. MEMBERS' RIGHT TO CONTINUE BUSINESS

The Members shall have the right to continue the business of the Company in the event of the death, incapacity, retirement, resignation, expulsion, bankruptcy, or dissolution of a Member or the occurrence of any other event that terminates the continued membership of a Member in the Company in the manner set forth in the Operating Agreement of the Company.

ARTICLE VIII. OPERATING AGREEMENT

The power to adopt, alter, amend, or repeal the Operating Agreement of the Company shall be vested in the Members of the Company.


