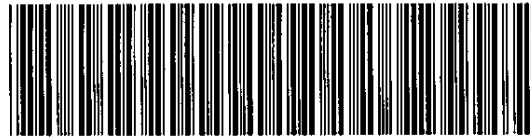

NAME**

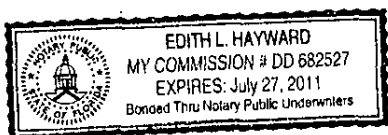

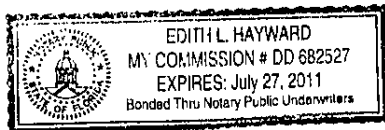


