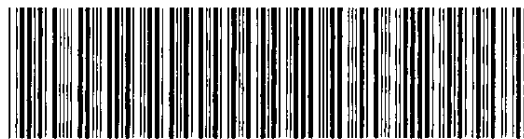

The Managers shall be elected annually in the manner prescribed in the Operating Agreement for this Limited Liability Company.


ARTICLE V -- GOVERNED BY OPERATING AGREEMENT

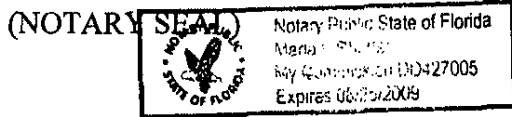
