**ARTICLES OF AMENDMENT  
to  
ARTICLES OF ORGANIZATION  
of  
KNOT REEL FISHING, LLC**

Pursuant to the provisions of Section 608.411, Florida Statutes, this Florida limited liability company adopts the following Articles of Amendment to its Articles of Organization:

1. The name of the limited liability company is Knot Reel Fishing, LLC (the "*LLC*").
2. The effective date of filing of the Articles of Organization (the "*Articles*") of the LLC was May 20, 2009.
3. The sole member of the LLC is Curtis H. Englert (the "*Member*").
4. The Member deems it to be in the best interest of the LLC to amend Article I to the Articles of the LLC.
5. That Article I of the Articles of the LLC is hereby amended in its entirety to read as follows:

**ARTICLE I  
NAME AND ADDRESS**

The name of the limited liability company shall be Four Reel Fishing, LLC (the "*Company*"). The mailing and street address of the principal address of the Company in Florida shall be 29 North Roscoe Boulevard, Ponte Vedra Beach, Florida 32082.

6. The foregoing amendment shall become effective as of the date these Articles of Amendment are filed with the Secretary of State of Florida.
