**ARTICLES OF ORGANIZATION**

Pursuant to the provisions of Chapter 608 of the Florida Statutes, the undersigned hereby declares the following provisions as the Articles of Organization of CCK MEDICAL, LLC, a Florida limited liability company (the "Company").

**ARTICLE 1: NAME AND MAILING ADDRESS**

The name of this Company is CCK MEDICAL, LLC, and its principal office and mailing address is 100 Second Avenue South, St. Petersburg, Florida 33701.

**ARTICLE 2: DURATION**

The duration of the Company is perpetual.

**ARTICLE 3: PURPOSE**

This Company has been organized for any lawful purpose under Florida law, except that special statutes for the regulation and control of specific types of business shall control when in conflict herewith.

**ARTICLE 4: INITIAL REGISTERED OFFICE AND AGENT**

The street address of the initial registered office of this Company is located at 100 Second Avenue South, Suite 701, St. Petersburg, Florida 33701 and the name of the initial registered agent is Robert Kapusta, Jr.

**ARTICLE 5: MANAGEMENT; INITIAL MEMBERS**

ARTICLE 8: OPERATING AGREEMENT




ARTICLE 9: TRANSFERABILITY OF MEMBER'S INTEREST


