ARTICLE I - NAME

The name of the limited liability company shall be STABLE MANAGEMENT, LLC ("Company").

ARTICLE II - ADDRESS

ARTICLE III - DURATION

The company shall commence its existence on the date these articles of organization are filed by the Florida Department of State. The company's existence shall be perpetual unless the company is dissolved as provided in these articles of organization.

ARTICLE V -- ADMISSION OF NEW MEMBERS

No additional members shall be admitted to the company except with the unanimous written consent of all the members of the company and on such terms and conditions, as shall be determined by all the members. A member may transfer his or her interest in the company as set forth in the regulations of the company, but the transferee shall have no right to participate in the management of the business and affairs of the company or become a member unless all the other members of the company other than the member proposing to dispose of his or her interest approve of the proposed transfer by unanimous written consent.

ARTICLE VI -- TERMINATION OF EXISTENCE

These regulations may contain any provisions for the regulation and management of the affairs of the company, not inconsistent with law or these articles of organization. ARTICLE VIII -- EFFECTIVE DATE

The effective date of the company shall be June 1, 2009.
