The name of the limited liability company is: Crofton L&D Meats, LLC.

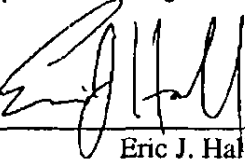
**ARTICLE II. ADDRESS**

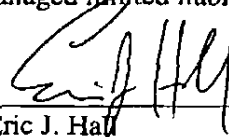
