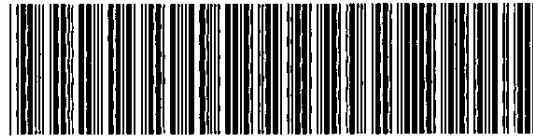

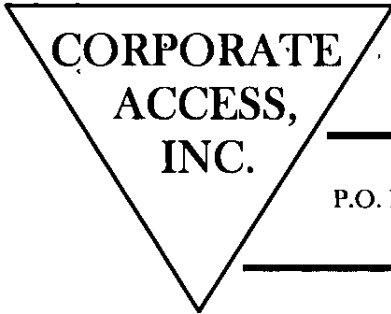

ARTICLE VII - AMENDMENT


