

On November 6, 2013 Articles of Amendment to Articles of Organization of Bramco LLC were filed by Rener Da Cunha. Mr. Da Cunha had no authority to add Shmuel Mann or "The SEDC Revocable Trust" as Managing Members of Bramco LLC. We were never provided any notice of this Amendment. We did not consent and agree to this Amendment. There is no such entity as "The SEDC Revocable Trust". It is presumed reference is made to the Stephen Enzo DaCunha Trust.

This resignation is made retroactive to and effective as of November 6, 2013 by Shmuel Mann and "The SEDC Revocable Trust" by the Stephen Enzo DaCunha Trust.
