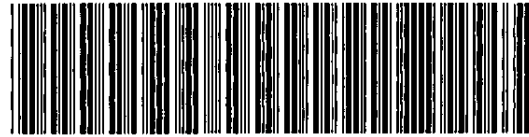

Diana Guerry placed him on the corporation papers without his knowledge. It is my understanding that she just picked names to fill in the blanks for positions on the corporation papers.


Diana Guerry was and is the sole owner/operator of Bling and Things LLC. All corporation papers, bank accounts, bank cards and business accounts associated with the business were in her name and her name only. All debts, bill, taxes and fees are her sole responsibility. Diana Guerry made ALL of the business decisions in her name as her right as owner.

No other person or persons named or unnamed on the corporations papers or any other papers associated with Bling and Things Boutique, LLC., hold any responsibility for any fees, taxes, fines, penalties or debts that were accrued in the name of Bling and Things LLC, or in the name of Diana Guerry. She has sole responsibility for these things.

Diana Guerry had friends and acquaintances that helped her at the store. They held no ownership of the business or responsibilities for its debts. They worked out of friendship and in exchange for selling some of their items at the store for a reduced commission from Ms. Guerry. Diana made it quite clear to everyone, especially before the business closed, that she was the ONLY owner and that everything in the store and including the store belonged to her and was in her name. This was especially evident when she closed the store, claimed all the remaining items in the store, sold many items at auction and the remainder as a whole sale deal and then pocketed all of the money.

In January of 2011, when sales taxes were due, I reminded her of the taxes several days before the due date. In fact, the week the taxes were due, Bling and Things Boutique LLC., had enough money in the bank account to pay the sales taxes due to the state and to pay all of the vendors and consignors at the store. I saw the bank account total along with another witness on January 17, 2011. That was the last date I worked in the store for Ms. Guerry.
