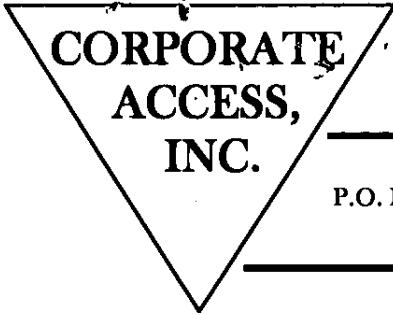

Article IV - Management



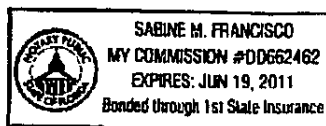


