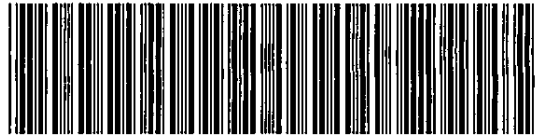




FIRST: Article V is amended and restated to remove SUHA F. DAOU as a Manager and to read as follows:
