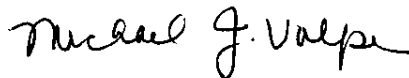

**ARTICLES OF ORGANIZATION
OF
TIKCO II, LLC**

THE UNDERSIGNED certifies he intends to form a limited liability company under the laws of the State of Florida and hereby declare that the following Articles shall be the Charter and authority for the conduct of business of such limited liability company.

**ARTICLE I
NAME**

The name of the limited liability company (the "Company") shall be **TIKCO II, LLC**.

**ARTICLE II
ADDRESS**

The mailing and street address of the Company's principal office is:

**ARTICLE III
PURPOSES**

The general nature of the business or businesses to be transacted and which the Company is authorized to transact shall be as follows:

- A. To retain, purchase, invest in and re-invest in any kind of property, without regard to the location, non-productivity, risk or lack of diversification thereof, including (without thereby limiting) real property, bonds, options, common stocks, preferred stocks, common trust funds, partnerships (both limited and general) and insurance on the life of any person all for the benefit of the members.
- B. To engage in any activity or business authorized under the Florida Statutes.
- C. In general, to carry on any and all incidental business; to have and exercise all the powers conferred by the laws of the state of Florida, and to do any and all things herein set forth to the same extent as a natural person might or could do.

**ARTICLE IV
DURATION**

The duration for the Company is perpetual.

ARTICLE V
REGISTERED AGENT AND OFFICE

The name of the Company's initial registered agent in Florida is **ROBERT L. WHITE**, and the address of the Company's registered agent in Florida is McDonagh Family Office, 25335 Luci Drive, Bonita Springs, Florida 34135.

ARTICLE VI
MANAGEMENT

The Company is to be managed by the members.

ARTICLE VII
ADMISSION OF NEW MEMBERS

Members of the Company have the right to admit new members. Additional members may be admitted only by the affirmative vote or written consent of a majority-in-interest of the members unless otherwise provided in the Company's Operating Agreement. The existing members shall determine the amount and nature of the contribution by new members at the time the new members are admitted.

ARTICLE VIII
CONTINUATION OF BUSINESS OPERATIONS

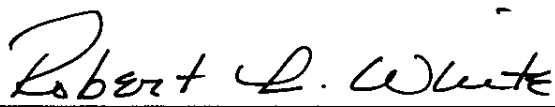
The Company may continue its business operations upon the death, retirement, resignation, expulsion, bankruptcy or dissolution of a member or the occurrence of any other event which terminates the continued membership of a member in a limited liability Company only upon the unanimous approval of the remaining members, unless otherwise provided in the Company's Operating Agreement.

ARTICLE IX
TRANSFERABILITY OF MEMBER'S INTEREST

A member's interest in the Company shall not be transferred unless the transfer is approved by the members in accordance with the Company's Regulations.

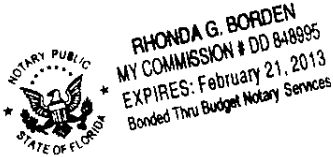

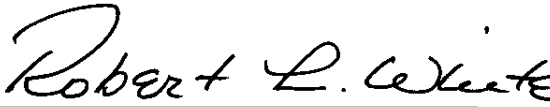
