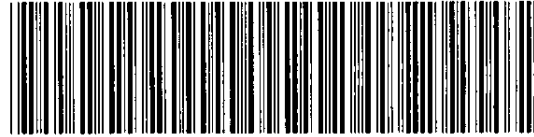

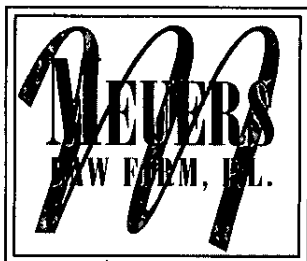

The undersigned authorized representative of a member of the above captioned Limited Liability Company, under the provisions of the Florida Limited Liability Company Act, Chapter 608, *Florida Statutes*, adopts the following Articles of Organization:

1. Name. The name of this limited liability company is Jon Ayres Baseball, LLC (the "Company").

2. Duration. The Company shall remain in existence from the date of filing of these Articles with the Florida Department of State until terminated in accordance with the provisions of the Florida Limited Liability Company Act or the Company's Operating Agreement.

3. Purpose. The Company is organized for the purpose of transacting all lawful activities and businesses that may be conducted by a limited liability company under the laws of Florida.

4. Place of Business. The mailing and street address of the Company's principal office is 28043 Eastbrook Drive, Bonita Springs, Florida 34135.

5. Registered Agent and Office. The name of the initial registered agent of the Company is Lawrence H. Meuers. The street address of the initial registered agent of the Company is 5395 Park Central Court, Naples, Florida 34109.

6. Additional Members. Additional members to the Company may be admitted, but only upon the unanimous consent of all members of the Company at the time admission is sought.

7. Termination of Membership. Upon the death, retirement, resignation, expulsion, bankruptcy or dissolution of a member or upon the occurrence of any other event which terminates the continued membership of a member in the Company, the Company shall be dissolved unless the remaining members, by unanimous written agreement, consent to continue the business of the Company.

8. Management of the Company. The Company shall be managed by a manager or managers in accordance with the regulations adopted by all of the members. The name and address of the initial Managing member, who shall

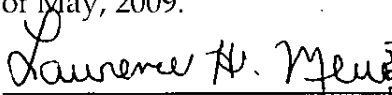
serve until the first annual meeting of the members or until his successors are elected and qualified, is:

10. Voting. The Company is authorized to issue membership units with voting rights and membership units without voting rights.

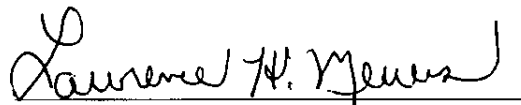
