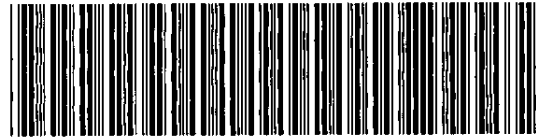

ARTICLE I: NAME


