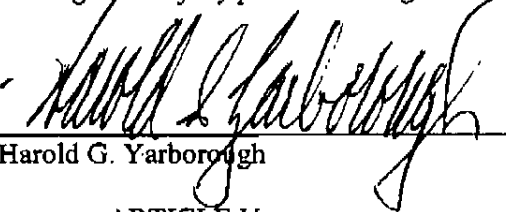

The Company is to be managed by one or more Managers and is, therefore, a manager-managed company.

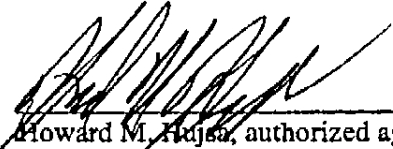
ARTICLE VI
