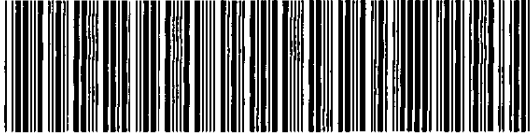


1. **Name.** The name of the limited liability company is KELLY DYNASTY, LLC.


