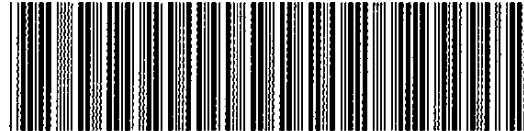

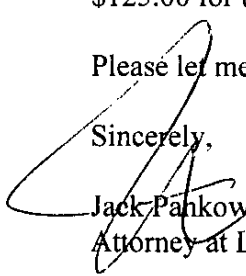

**ARTICLE II: ADDRESS**

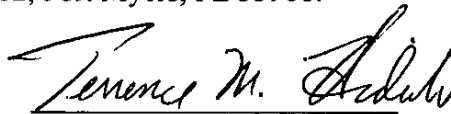

**ARTICLE III: DURATION**

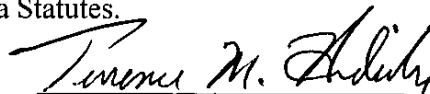
The company shall commence its existence on the date these Articles of Organization are filed by the State of Florida and shall exist perpetually, unless dissolved as provided in these articles.
