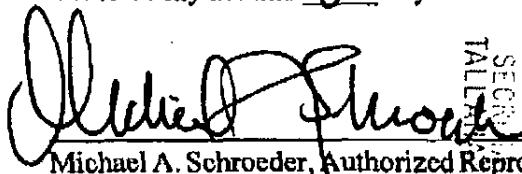
ARTICLE IV - MANAGEMENT OF BUSINESS

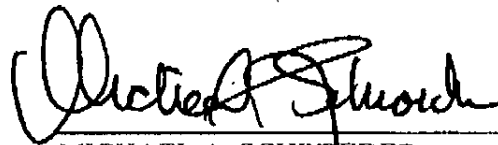
