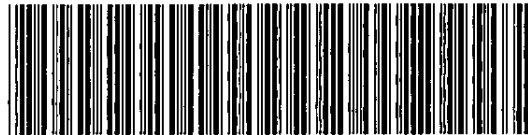

The Company is to be manager managed and the name and address of the initial manager is:

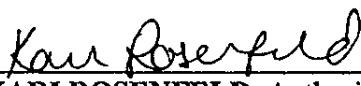

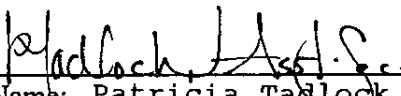
