

**ARTICLES OF ORGANIZATION
OF
EXCALIBUR PAINTBALL, LLC**

I, the undersigned subscriber to these Articles of Organization, being a natural person competent to contract, hereby execute this document for the purpose of becoming a limited liability company under the laws of the State of Florida.

ARTICLE I: NAME

The name of this limited liability company shall be:

EXCALIBUR PAINTBALL, LLC.

ARTICLE II: BUSINESS AND MAILING ADDRESS

The principal place of business of this limited liability company shall 8230 FL-GA Hwy, Havana, FL 32333, but it shall have the power to transact business in any other place or places both within and without the State of Florida and throughout the world. The mailing address of the limited liability company shall be 95 Forest Circle North, Havana, FL 32333.

ARTICLE III: REGISTERED AGENT



The foregoing and following provisions shall be construed as objects in furtherance and not in limitation of the general powers conferred by the laws of the State of Florida and the enumeration in these Articles of specific powers and objects shall not be held to limit or restrict in any manner the powers of this limited liability company; but this limited liability company may do all and everything necessary, suitable or proper for the accomplishment of any purpose or object, either along or in association with other limited liability companies, corporations, companies, partnerships, firms or individuals, to the same extent and as fully as individuals might or could do as principals, agents, contractors or otherwise.

ARTICLE V: DURATION

This limited liability company shall have perpetual existence, unless sooner voluntarily dissolved according to law.




