**ARTICLES OF ORGANIZATION
OF
INTEGRATIVE MULTISPECIALTY MEDICAL CONSULTANTS, PLC**

The undersigned, desiring to form a professional limited liability company under and pursuant to Chapters 608 and 621 of the *Florida Statutes*, entitled the "Florida Limited Liability Company Act" and the "Professional Service Corporation and Limited Liability Company Act," respectively (Collectively referred to as the "Act"), do hereby adopt the following Articles of Organization for such company.

**ARTICLE I
NAME**

The name of the professional limited liability company shall be "Integrative Multispecialty Medical Consultants, PLC" and is herein referred to as the "Company."

**ARTICLE II
ADDRESS**

The mailing address of the Company is 1576 Bella Cruz Drive, Suite 363, The Villages, Florida 32159; and street address of its principal place of business in Florida is 1576 Bella Cruz Drive, Suite 363, The Villages, Florida 32159, but it shall have the power and authority to establish branch offices at such place or places as may be designated by the members.

**ARTICLE III
DURATION/CONTINUATION**

The period of the Company's duration shall be perpetual, unless terminated by the unanimous written agreement of all members or as otherwise prescribed in the Company's Operating Agreement or in the Act.

**ARTICLE IV
PURPOSE**

The sole and specific purpose for which the Company is organized is to render professional service in the practice of medicine.

In addition, the Company shall have unlimited power to engage in and do any lawful act concerning any or all lawful businesses for which professional limited liability companies may be organized according to the laws of the State of Florida, including all powers and purposes now and hereafter permitted a professional limited liability company pursuant to Section 621.08, *Florida Statutes*.

ARTICLE V MANAGEMENT

The business of the Company shall be managed by its member The name and address of the original managing member is as follows:

ARTICLE VI RESTRICTIONS ON MEMBERSHIP

The sole Member shall have the right to admit new members by consent and in accordance with the Company's Operating Agreement. Contributions required of new members shall be determined as of the time of admission to the Company. A member's interest in the Company may not be sold or otherwise transferred except with unanimous written consent of all members. No person shall be admitted as a Member of the Company unless such person is a professional corporation, a professional limited liability company, or an individual, any of which must be duly licensed to practice medicine.

ARTICLE VII POWERS

All professional limited liability company powers shall be exercised by or under the authority of, and the business and affairs of this professional limited liability company shall be managed under the direction of, the members of the Company. The Company shall be managed by its sole Member and may elect officers pursuant to the operating agreement of the Company.

ARTICLE VIII OPERATING AGREEMENT

The power to adopt, alter, amend or repeal the Operating Agreement of the Company shall be vested in the sole Member unless otherwise designated by any amendments of the Articles of Organization.

ARTICLE IX AMENDMENT TO ARTICLES

Any amendment to these Articles of Organization shall be on such form prescribed by the Florida Secretary of State, containing such terms and provisions consistent with Sections 608 and 621 of the *Florida Statutes*, as shall be prescribed by the Department of State, and shall be signed and sworn to by all members of the Company. In the event a new member is added by such amendment, it shall also be signed by the member to be added.
