ARTICLES OF ORGANIZATION OF DWG FINANCIAL, LLC

The undersigned, for the purpose of forming a limited liability company under the Furda Limited Liability Company Act, F.S. Chapter 608, hereby makes, acknowledges, and file the following Articles of Organization.

ARTICLE I -- NAME

The name of the limited liability company shall be DWG Financial, LLC ("Company").

ARTICLE II -- ADDRESS

The company shall be dissolved on the death, bankruptcy, or dissolution of a member or manager, or on the occurrence of any other event that terminates the continued membership of a member in the company, unless the business of the company is continued by majority vote of the remaining members.

ARTICLE IX -- MANAGEMENT
