ARTICLES OF ORGANIZATION

OF

ASB PROPERTIES, LLC.

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby make, acknowledge, and file the following Articles of Organization.

ARTICLE I - NAME

The name of the limited liability company shall be ASB Properties, LLC. (the "Company

ARTICLE II - ADDRESS

The mailing address and street address of the principal office of the Company shall be 3396 N. Access Road, Englewood, Florida 34224.

ARTICLE III - DURATION
