The Articles of Organization of the More Liberty – Less Government Foundation, LLC are hereby amended as shown below.

---

The Limited Liability Purpose currently states "*Any and all lawful purposes*" That language is hereby replaced with the following language:

Amendment

The More Liberty – Less Government Foundation, LLC is organized exclusively for charitable, religious, educational and scientific purposes, including for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

Upon the dissolution of the LLC, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction for the county in which the principal office of the LLC is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
