## ARTICLES OF ORGANIZATION OF

### Exigen Technologies, LLC

The undersigned, for the purpose of forming a Limited Liability Company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby make, acknowledge, and file the following Articles of Organization.

#### ARTICLE I -- NAME

The name of the Limited Liability Company shall be Exigen Technologies, LLC ("Company").

#### ARTICLE II -- ADDRESS

The mailing and principal address of the Company: 8309 Gunn Highway Tampa, Florida 33626.

#### ARTICLE III -- DURATION

The Company shall commence its existence on the 9TH day of JUNE, 2009. The Company's existence shall be perpetual unless the Company is dissolved earlier as provided in these articles of organization or in the regulations.

A member may transfer his or her interest in the Company as set forth in the regulations of the Company, but the transferee shall have no right to participate in the management of the business and affairs of the Company or become a member unless all of the Members of the Company other than the member proposing to dispose of his or her interest approve of the proposed transfer by written consent.

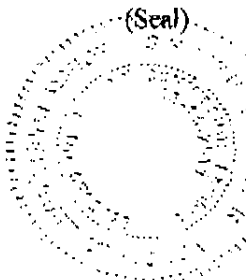

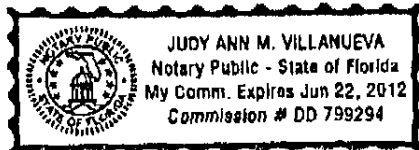
