ARTICLES OF ORGANIZATION OF CAVALIER MORTGAGE HOLDINGS, LLC

These Articles of Organization are made for the purpose of organizing a Florida Limited Liability Company under the Florida Limited Liability Company Act (Florida Statutes Chapter 608).

- 1. Name. The name of this limited liability company is CAVALIER MORTGAGE HOLDINGS, LLC.
- Duration. The latest date upon which the limited liability company is to dissolve is January 1, 2059.
