ARTICLE I

The name of the Company is ROB HAR, LLC.

The Articles of Organization were filed on June 16, 2009 and assigned document number L09000058381.

Pursuant to the authority contained in Section 608.441 and 608.4431 of the Florida Statutes, all of the Members and Managers of the Company entitled to vote thereon elected to dissolve the Company effective December 31, 2010.
